No monies shall be returned or credited if exhibitor cancels booth(s) within 60 days of event date.

I/We understand that this contract shall not become valid until it has been accepted by: Maple Show Productions Ltd. Management. **It is agreed by the exhibitor to provide floor covering for the contracted space** and to abide by all the conditions, rules and regulations as set out on this contract including cheques, and/ or credit card information and in all material concerning the Show. NSF cheques will incur a \$25.00 fee.

CONDITIONS, RULES AND REGULATIONS OF AGREEMENT

1. The Contract for Exhibit Space shall not become a binding contract between the Exhibitor and Maple Show Productions Ltd. (hereinafter referred to as "MSP") until the contract has been signed by MSP.

2. No one other than the official contractor, as designated by The International Centre, or such contractors as have been approved in writing by MSP, shall connect or disconnect utility service, install wiring, spotlights or do other electrical or carpentry work, and all such work shall be at the Exhibitor's expense.

3. No Exhibitor shall exhibit or permit to be exhibited in the space allotted to him any merchandise or service other than that specified in the contract.

The space shall not be sublet without the written permission of MSP and the sharing of space by the Exhibitor or use of the space by persons or in a matter not authorized by MSP is prohibited.

4. MSP shall have the right to adopt such rules and regulations as to the conduct of parties prior to, during and after the Show as in its discretion it deems to be in the best interest of the Show, and the Exhibitor agrees to abide by and be bound by all rules and regulations adopted by MSP as well as all rules and regulations of general application that may be issued by The International Centre and all bylaws, rules, directions, orders and regulations of Peel Regional Police, Fire Department and/or other Municipal authorities. References to MSP herein shall be deemed to include any duly authorized representative, agent or employee of MSP.

5. The Exhibitor shall obtain and maintain at its own expense a comprehensive general liability and all risk property insurance policy acceptable to MSP for the period commencing on the first move-in date and terminating on the last move-out date. The policy shall name MSP as additional insured and insure the Exhibitor against all claims of any kind arising from or in any way connected with the Exhibitor's presence or operations at the Show. The policy shall provide coverage of at least \$1,000,000 for each separate occurrence. At the request of MSP, the Exhibitor shall provide MSP with a copy of such a policy. b) The Exhibitor is responsible to insure its own exhibit, personnel, display and materials from any damage or loss through theft, fire, accident or other cause and accepts all risks associated with the use of the exhibit space and its environs. The Exhibitor shall not make any claim or demand or take any legal action, whatsoever, against MSP, the Show sponsors or the facility in which the Show is held, for any loss, damage or injury howsoever caused, to the Exhibitor, its officers, directors, agents, representatives, and employees or their respective property. c) Neither MSP nor the facility will assume liability for loss for damage, through any cause, or equipment, products, goods, exhibits or other materials owned, rented or leased by the Exhibitor.

6. If the Exhibitor fails to comply in any respect with the terms, conditions, rules or regulations of this contract, all rights of the Exhibitor hereunder shall cease and terminate. Any payment made by the Exhibitor on account hereof will be retained by MSP as liquidated damages for breach of this contract and MSP may thereupon rent the space. Once the contract has been signed by both parties, the entire rental for the space becomes payable in terms hereof. All and any moneys paid are non-refundable.

7. Should any contingency interrupt or prevent the holding of the Show including but not limited to acts of God, strikes, lock-out or other labour or individual disturbances, riots, failure to secure materials or labour, fire, lightning, tempest, flood, explosion or any other cause, then MSP shall in no way whatsoever be liable to the Exhibitor, other than to return such portion of any amounts paid as may be determined to be equitable by MSP, in its sole opinion, after deduction of such amounts as may be necessary in MSP's sole opinion, to cover all expenses incurred by MSP in connection with the Show and/or promotion and publicity.

8. If for any reason MSP determines that the location of the Show should be changed or the dates of the Show postponed, no refund will be made but MSP shall assign to the Exhibitor, in lieu of the original space, such other space as MSP deems appropriate and the Exhibitor agrees to use such space under the same rules and regulations.

9. The Exhibitor will exhibit in a proper manner, and will keep the Exhibit Space open and staffed at all times during the Show hours. MSP reserves the right to restrict exhibits to a maximum noise level and to suitable methods of operation and display.

MSP shall have the final decision as to what constitutes a proper exhibit and such decision shall be final and binding. If for any reason an exhibit or its contents are deemed objectionable by MSP, the exhibit will be removed without refund of any amounts paid. This provision includes persons, things, conduct, printed matter or any item or attire which MSP may consider objectionable to the Show's intent. MSP further reserves the right to relocate exhibits or exhibitions when in its opinion such, relocations are necessary to maintain the character and/or good order of the Show.

10. The Exhibitor agrees that no display may be dismantled or goods removed during the entire period of the Show by same. The booth display must remain intact until the closing hour of the last day of the Show. The Exhibitor agrees also to remove its exhibit, equipment and appurtenances from the Show Building by the final move-out time limit, or, in the event of failure to do so, Exhibitor agrees to pay for such additional costs as may be incurred.

11. The Exhibitor shall not insert nails, hooks or screws into the walls and floors of the Building and the Exhibitor shall be liable for any damage caused to the Building floors, walls, or columns or to the property of other exhibitors. The Exhibitor may not apply paint, lacquer, adhesive or other coatings to Building columns nor shall use any flammable decorations or covering for display fixtures, and all fabrics or other material used for decoration or covering of tables and/or risers shall be flame proof.

12. No signs or advertising devices shall be displayed in areas of the Building other than those set aside for such purposes and all such signs shall be subject to the approval of MSP.

13. The Exhibitor shall abide by the terms and conditions of all and any agreements and/or contracts existing between MSP, The International Centre and each and every Union and/or Labour Organization relating to the staging of the Show, and will obtain any clearance required by any union or trade organization having authority with respect to the Show or work performed in the Building.

14. The Exhibitor shall not

- a. Commit any nuisance.
- b. Cause any unusual noxious or objectionable smoke odour to emanate from its Space.
- c. Use its Space for lodging or sleeping.
- d. Do anything which would interfere with the effectiveness of any utility, the heating, ventilating or air-conditioning systems in the Building nor interfere with free access or passage to the public areas of the Building or areas adjoining thereto.
- e. Interfere with the effectiveness of or accessibility to the escalators in the Building or the electrical, plumbing, gas or compressed air systems.
- f. Overload any floor, ceiling or wall.
- g. Do or permit to be done any act which might invalidate any insurance policy carried by MSP or The International Centre.
- h. Take up a collection.

15. In the event the Exhibitor has not brought in its display prior to the time set out by MSP, then MSP has the sole discretion to determine whether the Exhibitor may be deemed to be in breach of this contract and may be prohibited from entering into the Building and setting up its display. MSP may at its sole discretion retain the monies paid as liquidated damages.

16. The Exhibitor will confine its activities to the Exhibit Space and will not solicit beyond the boundaries thereof.
